ABOUT THE PRODUCT

WARRANTY COVER

JK Trendz Tru-Shyn Emulsion warranty cover for interior paints performance is as under,

COMMENCEMENT

1. This warranty shall commence from the date ("the Commencement Date") of completion of the painting.
2. If there is a break or recess period in the painting work on the same building, finalizing the commencement date shall be at the discretion of the Company (JKMaxx Paints Limited).
3. The Company at its own discretion may appoint a person to inspect and validate the application of the painting system as per the directions specified.
4. Where any claim arises during the warranty period, the period will not start afresh after the settlement of the claim.

EXTENT OF WARRANTY*

The warranty shall apply where:

- a. For high volume sites, greater than 60 litres of paint and primer, the warranty is applicable, subject to satisfactory pre-inspection of the interior surface to be painted, by the company's representative.
- b. The company will only provide replacement paint for re-application of the coating, as may be necessary to set right the paint failure in the affected portion only, in accordance with the liability as indicated in the 'Liability' section.
- c. Throughout this warranty the words "Paint Failure" shall mean any of the following occurring, subject to the other conditions laid under this warranty: -
 - i. Film Integrity (Peeling / Flaking): Paint film cracking / flaking off from the composite system / Primer coat
 - ii. Shade Retention: Visible change in colour due to natural weathering.
 - iii. Fungal growth: Growth of fungus on wall surfaces* (at least spread over a minimum area 1 sq.mt (10 sq. feet)
 - iv. Sheen: Visible drop in sheen due to natural weathering

WARRANTY PROCESS

Customers can register warranty through the JKMaxx Paints website.

Process for registering through the JKMaxx Paints website:

- Fill in all the required details asked for warranty registration
Once all details are verified, the customer shall get a soft copy of the warranty document on their registered email ID & a physical copy within 24 hours of registration.

APPLICATION

The product warranty up to 8 years is applicable only under the following conditions:

- a. JK Trendz Tru-Shyn has been used on the interior masonry wall surfaces only.
- b. It shall be mandatory to have applied an undercoat of JK MaxX Paints Primera Interior Primer, subsequently followed by at least 2 top-coats of JK Trendz Tru-Shyn.
- c. The customer has used the entire paint system recommended by the company as given in the directions for use section. Final coverage obtained post the correct usage should be between 120-130 sq. ft./Ltr.

EXCLUSIONS

The Warranty will cover only manufacturing defects of JK Trendz Tru-Shyn coating Systems & will not cover any defects arising out of factors out of control of the Warrantor, including but not limited to:

- a. Paint failure due to structural defects/cracks & damage of the film due to high abrasion of the surface with furniture, nails, or other sharp objects, abuse, or negligence by the customer.
- b. Cracks arising due to joinery works at joint location for any substrate, structural cracks or any cracks with width greater than 0.05 mm
- c. De - bonding of the base (material used for levelling) from the surface & cracks formation on the same.
- d. The substrate being affected by high alkalinity, water seepage, constant/rising dampness in the substrate, frosting or efflorescence, constant submersion in water, or water condensation resulting from temperature gradients.

- e. Paint applied on the surface being contaminated, following an improper painting system, or inadequate curing time for the paint film to dry.
- f. Usage of improper shade recipes or incorrect bases for tinting colours (other than white shade).
- g. Improper surface preparation and/or application.
- h. Any act or omission on the part of the Contractor or Customer causing Paint to be defective by any means.
- I. Excludes warranty for washability-complete removal of stains, removal of burnish marks, variation in sheen of coating post cleaning / abrasive actions, etc.

For cleaning of painted surface, use mild detergent solution (< 2 % concentration) and soft cloth / sponge to remove dust, dirt and stains of non-penetrating nature. Stains are best removed when cleaned up immediately. Performance on stain cleanability will vary with type of stain and retention of stain on surface, hence not covered. Painted surface is not to be subjected to cleaning with harsh chemicals or cleaning agents based on acid/alkali, peroxides or corrosive materials.

Damage to the coating system caused by external factors, including but not limited to deterioration of the systems caused by external factors including, but not limited to, normal wear and tear, vandalism, improper cleaning or improper use, point loads or mechanical causes, fire, explosion, vibration, structural defects and/or movement, lightning, thunderbolt, acts of God, natural calamities such as earthquake and all other unusual occurrences.

LIABILITY

1. The company's performance warranty liability will reduce over the warranty period according to the below mentioned scale:

- a. The replacement cost, material and labour cost combined, shall be limited to the cost of the paint and labour required to set right the area of paint failure only, at the time of the lodgement of claim.

- b. The labour rate will be determined by the company, and it will be a reflection of the current prevailing market labour rates and the same will not be disputed by the customer at any point of time. The labour rate may be determined on the basis of a per sq.ft. rate or on a daily wages rate. The customer will be liable for the balance costs, which are not company's obligations, as indicated above.
- c. The company will not be liable for any losses, claims, demands, suits, proceedings, damages, costs, expenses, liabilities, including but not limited to, losses or damages to real and tangible property (direct or indirect) or consequential loss to the customer. The customer's exclusive and sole remedy under this Warranty shall be as mentioned in the forgoing clauses. This clause shall survive the termination of this agreement.

CLAIMS AND REPAIRS

- a. Any claim made under the terms of this warranty shall be made within 30 (thirty) days of the consumer discovering any defect, damage, or failure which gives rise to a claim.
- b. The consumer shall forthwith notify the company of the claim, providing full details thereof and shall set out the basis on which they believe that the company is liable under the terms of the warranty. The company reserves the right to carry out inspections of the paint application process in which the painting system is alleged to have failed and perform any tests in respect thereof and may do so either itself or by means of any person nominated by the company. Prior to such an inspection or testing, the consumer shall not be entitled to perform any repairs to or remove or tamper with any part of the painting system.
- c. The contractor or consumer shall forthwith notify JKMaxx Paints of the claim providing full details thereof and shall set out the basis on which they believe that JKMaxx Paints is liable under the terms of the warranty. JKMaxx Paints reserves the right to carry out inspections of application process, in which the paint, JK Trendz Tru-Shyn, is alleged to have failed and to perform any tests in respect thereof and may do so either itself or

by means of any person nominated by it. Prior to such inspection or testing, the customer and/or contractor shall not be entitled to perform any repairs to or remove or tamper with any part of the JK Trendz Tru-Shyn.

- d. The Company shall use its best endeavors to ensure that the paint required for repairs is available as soon as possible at the place where the repairs are to be carried out, but does not assume liability for delay in this respect.
- e. The Company, in its sole discretion, shall be entitled to:
 - i. Control/monitor re-painting which is to be carried out in accordance with all its specifications and instructions; and
 - ii. Appoint a contractor and / or approve the contractor appointed by the Customer.

MISCELLANEOUS

- a. This Warranty disclaims any liabilities, contracts, tort or otherwise including negligence and strict liability, and the company makes no warranty or merchantability of fitness for any particular purpose whatsoever for painting system. There are no warranties expressed or implied under law, which extend beyond the warranty set out herein.
- b. If any dispute arises between the company and the customer, with respect to the above warranty, neither shall commence any court or arbitration proceedings relating to the dispute unless they have first complied through mediation.
- c. In case of any disputes, the same is subject to exclusive jurisdiction of the courts of Delhi.
- d. The facts and all matters concerning any dispute will be kept confidential by both the customer and the company at all times.
- e. Warranty terms constitute an agreement between the customer and company and supersede any and all prior or contemporaneous, oral or written representations, understandings, or agreements. No modifications or amendments of this warranty shall be binding unless agreed to by the parties in writing.

HOW TO REGISTER YOUR WARRANTY

- a. To register the warranty, please visit JKMaxx paints website, within 15 days from the date of purchase of Maximo Ultra
- b. Keep the following information ready. This will help the Company to log Customer Warranty electronically, so that the Company can issue Customer Warranty Identification Number:
 - i. Customer name and contact details (contact number and e-mail id) for us to send the warranty certificate
 - ii. Site Address
 - iii. Volume of Maximo Ultra used
 - iv. Invoice details, i.e Name of the retailer, Invoice Number, Date of Purchase, etc
 - v. Name and contact number of the contractor who applied Maximo Ultra
 - vi. Brand and volume of Primer used
- c. We will also push a link in SMS form at your contact number wherein you are required to put all the above details for warranty registration
- d. The warranty no. shall be shared if paintable surface is <25000sqft. In case the paintable surface is >25000sqft, a site inspection by JK technical representative will be mandatory for issuing warranty no.
- e. Warranty no. is for acknowledgment only. Settlement of warranty claim will be subject to technical visit and clearance post logging of claim.
- f. Warranty no. will be shared via e-mail
- g. Should you ever experience a problem or have any questions regarding the Warranty, call on 1800-203-4555 and keep this Warranty document with your unique Customer Warranty Number and invoice at hand
